### 2. Contract with Placer.ai

A contract was entered into between the RTA and Placer.ai on 10/27/2023 for an annual contract of \$45,692. The initial 13-month term invoice totaled \$54,573.75 with tax. Board approval is required for all contracts in excess of \$50,000.

Placer.ai is a GPS data collection company that provides regional visitor location and path of travel data.

RECCOMENDED MOTION: To authorize the RTA CEO to execute a contract with Placer.ai for the period 10/27/2023-11/26,2024 for a total of \$54,573.75.
