- i. COLA increase, effective January 1, 2023 of 7.3%. The cities represented by the RTA have all implemented COLA increases effective 1/1/2023. The 7.3% COLA increase is an average of the three cities: Tukwila: 8.8%, Des Moines: 8.0%, SeaTac 5%.
- ii. Annual Wage Pay Schedule steps reflecting COLA increase.
