RECOMMENDED MOTION: I move to authorize the President/CEO to negotiate and/or execute agreements with the City of SeaTac and the Seattle Southside Chamber of Commerce for terms and amounts as presented.

It is anticipated that there will be some recommendations for policy changes and implementations as a result of the accountability audit.

- 5. The City of SeaTac and the RTA have decided to re-name the SeaTac International Dining District the "World Table District City of SeaTac, A Global Dining Experience".
- 6. SeaTac BMX hosted the 2025 Northwest Gold Cup Finals September 12-14. 5,000 attendees and close to \$2mil in economic benefit for the region.
- 7. Expanded "Hospitality Heroes" and a newly created "Best of Seattle Southside" will be showcased at an event in February in collaboration with the Chamber's business awards.
- 8. Valerie Skubal has been nominated by City Nation Place for their Future Leader award, Valerie is one of 3 finalists for this award. The RTA was nominated for Best Communication Strategy Tourism Award. We are a prior winner at this event.
