### 6. President's Report

**1. State of Washington Audit Report and final year 2022 financial statements** *M. Everton, CEO* The 2022 fiscal audit was completed by the State Auditor's Office and has been published on the State website. The State will schedule an exit meeting with the board later this fall.

No action needed. Minutes will reflect that a copy of the audit was made available to the board.

#### 2. Financial Statements and Budget

- a. The YTD July preliminary financial statement
- b. A 2023 year end financial forecast
- c. The 2024 proposed financial budget

#### Forecasted 2023 year end results:

- Revenue slightly above budget, primarily due to investment income.
- Expenditures below budget by \$615k.
- Fund balance will increase by \$652k.

# 2024 Budget:

- Revenue will decrease from 2023 by <\$300k> due to one-time King County funding of \$425k in 2023.
- Expenditures will increase \$784k over 2023 to capitalize on branding and regional awareness campaign.
- Staff increase of 1 position and staff salary increases consistent with salary steps and COLA increases.
- Fund balance will be stable at \$3.5 mil at year-end 2024

RECOMMENDED MOTION: I move to approve the proposed 2024 budget reflecting a reduction in fund contribution of <\$1.485 million>.

#### 2. Informational -

- a. Propose creation of a 'Program Development Advisory Committee'. PDAC may consist of 2-3 board members and 4-6 industry professionals. Focus on identifying programs and initiatives the RTA can undertake to promote meetings, corporate travel, sporting events and participation, promote limited service properties, market accessible travel.
- b. 100 Best Workplaces in Washington State for 2023/2024 event on August 17 was very successful. Our sponsorship of the event and photo booth yielded strong regional awareness.
- c. The Seattle Southside Chamber SEA Luncheon was held on 9/7. As a sponsor we were able to highlight our region's recovery via an economist's presentation. We also recognized our Hospitality Heroes.

- d. The 'Station Domination' takeover of the SeaTac light rail station has come to an end. The station was covered in Explore Seattle Southside posters, gels and wraps for most of the summer. Tens of thousands of visitors to our region were exposed to our region.
